#### IPPNW MEETS WITH WHO DIRECTOR-GENERAL

### DR. TEDROS GHEBREYESUS SUPPORTS UPDATE TO 1987 REPORT AND ADVOCATES FOR NUCLEAR WEAPONS ABOLITION


In 2023 IPPNW-Geneva Liaison Office Director, Chuck Johnson, began asking colleagues and other experts about whether to act on something that had been on IPPNW's agenda for a while, wondering, is now the time to encourage the World Health Organization (WHO) to update their decades-old report "Effects of Nuclear War on Health and Health Services?"

WHO's previous report has not been touched since 1987 and a new report has been needed for some time to include, among other things: extensive new computer modeling of the climatic, environmental, agricultural and nutritional effects of nuclear war; conclusions about the capacity of emergency responders to nuclear detonations, studies of health effects upon second generation survivors, and on ionizing radiation's impact upon women, girls, and children; updating the status and risks of current nuclear arsenals; and, emphasizing the responsibility of health professionals in preventing nuclear war.

An update of this baseline report from WHO now will be a clear message to the world that the nuclear weapons threat is not merely a relic of the Cold War past, but a current existential danger that health professionals prioritize and take seriously.

Chuck spoke with scientists at WHO's radiation and health unit, who expressed interest in the much-needed update. Our team also reached out to an author of the original report (and the only one still living), Dr. Frank von Hippel, who agreed to serve as an advisor to the new report.

On April 12, Chuck and staff from ICAN met with Dr. Tedros Ghebreyesus, Director-General of the World Health Organization. We were thrilled by his enthusiastic response. Without prompting, Dr. Ghebreyesus stated he will prioritize the update of WHO's 1987 report on the health impacts of nuclear war -and offered to join our advocacy for nuclear weapons abolition.



As the United Nations' agency charged with spearheading international public health efforts, WHO's involvement will undoubtedly impact our movement in a transformative way. WHO advocating by our side to do away with the most destructive force on our planet as we hold aloft an updated scientific report will amplify our message. During our meeting, Dr. Ghebreyesus shared his oft repeated quote, "We cannot have peace without health and we cannot have health without peace." We could not agree more!



We look forward to working with WHO to bring a resolution for the report's updating to the floor of the World Health Assembly (WHA) in Geneva the last week of May. On May 31, IPPNW will host a side-event at the WHA, where we will brief delegates on the humanitarian impacts of nuclear weapons and the urgency and importance of an updated WHO study. Our team was thrilled by his enthusiastic response. #### CALL FOR CEASEFIRE IN ISRAEL-PALESTINE



IPPNW calls for a ceasefire in the Israel-Palestine war. Our goal is the health, peace and security of all people, whether they live amid the terror and destruction of war. Our profession has its roots deep in our ethical obligation to provide care to all on the basis of their shared humanity and their need.

The targeting of hospitals, ambulances and health professionals undertaking their vital work is a heinous crime and a violation of the Geneva Conventions. Depriving health

services of the electricity, water, fuel and other supplies that they need to work is inhumane and a war crime. The UN has been clear that attacks on these facilities with the excuse that they may be in close proximity to combatants is also a violation of international law.

We express our support and deep gratitude and concern for our health professional colleagues in Gaza. Moreover, we are deeply disturbed by the irresponsible threat of nuclear weapons use made by the Heritage Minister of Israel. The risks of this war escalating uncontrollably to use nuclear weapons is a real and present danger.

We strongly support the consistent calls of the United Nations General Assembly and Secretary-General and humanitarian organisations for an immediate humanitarian ceasefire, for the immediate and unconditional release of all civilians held hostage by Hamas, many of whom need urgent medical attention, and for the protection of civilians and the infrastructure they rely on.

# IPPNW AND MEDICAL JOURNALS ISSUE URGENT CALL FOR ELIMINATION OF NUCLEAR WEAPONS

More than 150 medical journals, including the Lancet, the British Medical Journal, the New England Journal of Medicine, and JAMA have issued a joint call for urgent steps to decrease the growing danger of nuclear war and to move rapidly to the elimination of nuclear weapons. At a time of expanded fighting in Ukraine and Gaza, and increased tensions in Korea, leaders of the global health community underscore that any use of nuclear weapons would be catastrophic for humanity.



This unprecedented call to action comes in the form of an editorial co-authored by the editors of 11 of the leading medical and health journals, the World Association of Medical Editors, and leaders of the International Physicians for the Prevention of Nuclear War (IPPNW). The editorial was released last fall and has sparked increased interest among health professionals and activity between IPPNW and international health organizations.

In response to this editorial call to action, pediatric neurosurgeon Dr. Ruth Mitchell, IPPNW-Geneva Liaison Office's President, was invited to speak at the 17<sup>th</sup> WHO-Radiation Emergency Medical Preparedness and Assistance Network (REMPAN) in Seoul, South Korea on 13 September 2023. Dr. Mitchell addressed delegates on the role of health professionals in preventing a nuclear war and was well received, helping to initiate greater collaboration with Radiation and Health section of WHO.

#### **Keep Nuclear Power Plants Out of War Zones**

Vienna: In August 2023, IPPNW staff, board members, and medical students were key participants in the preparatory conference for the Non-Proliferation Treaty in Vienna. During his speech to the delegates, Co-President Carlos Umaña, IPPNW warned that "the war in Ukraine has highlighted the dark side of the nuclear era, with an ever-greater risk of a nuclear disaster, including the unprecedented situation of having nuclear power plants within a war zone." A strong statement in the Chair's Report on the danger posed at the Zaporizhzhia Nuclear Power Plant, supported by the International Atomic Energy Agency, was blocked due to a lack of consensus, continuing the frustration of many with the inability of the Treaty members to take decisive actions.

# **NUKEEXPO KICK-OFF A SUCCESS: IPPNW Speaks** and Hosts Booths at First Nuclear Disarmament Fairs

Brussels and Oslo: IPPNW physicians, medical students, and staff members gathered in Brussels and Oslo in April for *NukeExpo*, an immersive and interactive conference on the dangers of nuclear weapons, hosted by International Committee for the Red Cross and Norwegian People's Aid. IPPNW Co-President, Dr. Carlos Uma $\tilde{n}$ a, addressed the first plenary in Brussels, defending the Treaty on the Prohibition of Nuclear Weapons as ultimately more realistic and reliable than continuing to depend upon nuclear deterrence and unstable leaders to prevent nuclear war indefinitely. IPPNW ran education stalls in the "impacts" and "response" sections of the exhibition, focusing on the humanitarian impacts of nuclear weapons and the inability of health services to adequately respond to any use of these indiscriminate weapons. We hope to replicate the expo in other key countries.


